Major Policy Implementations for October 2025

- 1. On October 9, Executive Yuan Convener Cho Jung-tai chaired the 5th meeting of the "National Chemical Substance Management Board." The meeting addressed key topics including "Implementation Results of Hazardous Chemical Substance Management and Disaster Response Committees Established by Municipal and County Governments," "Continuous Improvement of Occupational Safety and Health Management of Chemical Products at Domestic Facilities," and "Post-Disaster Cleanup of Damaged Asbestos Building Material Waste."
- 2. On October 8 and 20, four sessions of "2025 Educational Training on Chemical Hazard Classification and Safety Information Communication for Toxic and Concerned Chemical Substance Operators" were conducted to help operators understand the key revisions of the new CNS 15030 standard and clarify common enforcement questions regarding the "Regulations for the Labeling and Safety Data Sheets for Toxic and Concerned Chemical Substances."
- 3. On October 11, a household pesticide awareness campaign was held at Jianguo Flower Market. Professor Sun Yan-zhang and Professor Hsu Err-lieh from National Taiwan University were invited to deliver presentations on "Home Control of *Dolichoderus thoracicus*" and "Home Environmental Pest Control and Safe Use of Household Pesticides," educating the public on methods for controlling *Dolichoderus thoracicus* at home and proper concepts for safely using household pesticides.
- 4. On October 14, 15, and 21, three sessions of "Joint Prevention Organization Training Workshops" were held in the northern, central, and southern regions, respectively. Regional Joint Prevention Organization operators were invited to participate in sharing chemical disaster case studies, facility guidance procedures, unannounced testing processes, and common deficiencies to enhance emergency response capabilities.

- 5. From October 18 to 19, the "2025 Green Chemistry Elementary School Camp Activities" were held with 64 elementary school students participating. The theme centered on green chemistry and environmental sustainability, with special guest lecturers including winners of the "Green Chemistry Application and Innovation Award" to expand the promotional benefits and value-added applications of the Chemical Administration's related awards.
- 6. On October 29, a forum on chemical substance registration, online payment, and system function was held. To simplify administrative work and serve the public, providing supplementary information and application for revocation online functions were activated on the Chemical Substance Registration Platform, with plans to establish online payment functionality on an electronic payment platform in 2026. A total of 71 people participated.
- 7. From October 29 to 31, the "2025 Resilient Taiwan -- International Forum on Resilience Technology for Environmental Accidents, Disaster Prevention and Response" was held. In addition to arranging awards and recognition for outstanding operating facilities and joint prevention organizations, domestic and international experts from the United States, Japan, and other countries were invited to share topics on lithium battery operation management and emergency response, strengthening Taiwan's toxic chemical disaster prevention and response capabilities.
